A regularly scheduled meeting was held on September 30, 2019, at 9:00 a.m. in the office of the Retirement Association – 750 Attucks Lane, Hyannis, MA 02601.

Board Members Present: Judith Sprague – Advisory Member/Vice-Chairman, Robert F. Rolanti – Elected Member, Ronald Bergstrom, Commissioner's Appointee, Harold S. Brunelle – Elected Member. The record is noted that the Ex-Officio/Chairman position is currently vacant.

Other Present for Board: Christine A. Tetreault - Executive Director, James H. Quirk, Jr. - Board Counsel

Vice-Chairman Sprague called the meeting to order at 9:00 a.m.

Executive Session:

Vice-Chairman Sprague announced pursuant to M.G.L. chapter 30A, section 21 (a)(1) the Board will convene in executive session to review, discuss and/or vote on the disability retirement application of Patricia Medina and the Accidental Death Benefit application of Sarah Sturgis as these matters involve the physical and/or mental health of the individuals. Vice-Chairman Sprague announced the open meeting will reconvene after Executive Session.

On a motion by Mr. Bergstrom, second by Mr. Rolanti, it was voted by roll call vote 4-0 to enter into Executive Session at 9:01 a.m. Roll Call: Judith Sprague – Yes, Robert Rolanti – Yes, Ronald Bergstrom – Yes, and Harold Brunelle – Yes.

Return to Open Session at 11:20 a.m.

Review/determine retirement eligibility under M.G.L.c. 32

It is noted that Mr. Jeff Jaran has patiently waiting for his matter to be addressed by the Board since 9:00 a.m.

On a motion by Mr. Bergstrom and second by Mr. Rolanti, it was voted to take the agenda out of order to review and determine the retirement eligibility under M.G.L.c.32 of Jeff Jaran. Motion unanimously passed.

Mr. Jaran is present for the discussion. Mr. Jaran was the Provincetown Police Chief who terminated service in May 2016. He subsequently retired on June 9, 2019 upon reaching age 55 with 6 years and 11 months creditable service and received his first retirement allowance check on July 31, 2019. This matter was brought to the Board's attention for review. Atty. Quirk advised the Board that Mr. Jaran does not meet the eligibility requirements under M.G.L.c. 32 § 5 as he was not a member-in-service or on an authorized leave of absence upon attaining age 55 nor does he meet the eligibility requirements under M.G.L. c.32 § 10 as he did not meet the minimum of 10 years creditable service upon termination requirement. Atty. Quirk finds no provision under M.G.L. c. 32 allowing Mr. Jaran to collect a retirement allowance. Atty. Quirk explained to Mr. Jaran that the Board has a duty under § 20 of c. 32 to correct errors when they are discovered.

Mr. Jaran addressed the Board. He states he spoke with the retirement board office in 2016 and was told he could come back and retire at age 55. Mr. Jaran believes he should have recourse and damages if the Board rescinds the benefits claiming he has made life decisions based on information provided by this office. The Board sincerely apologized for the misinformation he was given but must uphold the provisions of law. Atty. Quirk assured him he has appeal rights that will be provided to him.

On a motion by Mr. Bergstrom and second by Mr. Rolanti, it was voted to rescind/revoke the superannuation retirement allowance of Jeff Jaran whereas he does not meet the eligibility requirements under M.G.L. c. $32 \ \S \ 5$ or 10. Motion unanimously passed.

On a motion by Mr. Rolanti, seconded by Mr. Bergstrom it was voted to adopt the Collins Center Policies & Procedures report to be incorporated into the BCRA Personnel Policy. Motion unanimously passed.

The Board reviewed the proposed amended BCRA Personnel Policy recommended by Ms. Tetreault that includes the recommendations from the Collins Center and revisions necessary due to the separation between the County and BCRA.

On a motion by Mr. Rolanti, seconded by Mr. Bergstrom, it was voted to approve the amended BCRA Personnel Policy. Motion unanimously passed.

The Board reviewed the proposed RFP's for Actuarial and Independent Auditing Services submitted by Ms. Tetreault. If approved both will be advertised on PERAC and the BCRA websites.

On a motion by Mr. Bergstrom, seconded by Mr. Rolanti, it was voted to approve the Actuarial and Independent Auditing Services Request for Proposals. Motion unanimously passed.

Ms. Tetreault informed the Board that the Election Committee met on 9/20/19 and determined only 1 candidate was nominated for the BCRA election. The Election Committee has declared Robert F. Rolanti to be the Elected Member of the Barnstable County Retirement Board for a three-year term commencing 1/1/20 and ending 12/31/22, and therefore no election need be held. Mr. Rolanti was congratulated by the Board.

Mr. Bergstrom informed the Board that the County Commission had tabled the appointment of a new Ex-Officio/Chairman to the Board. He asked that a copy of M.G.L. c. 20C be forwarded to him so he can refer to the law when the County Commission takes the matter up again. He hopes to have a replacement of the ex-officio member by the October meeting.

On a motion by Mr. Bergstrom, second by Mr. Rolanti, it was voted to adjourn at 1:43 p.m. Motion unanimously passed.
